WHEREAS: the Vadenais Heights municipal election for mayor (two year term) and two council members (four year term) was held in conjunction with the 2024 General Election;

WHEREAS: per resolution 24-02-09 a write-in candidate wishing their votes to be recorded would have needed to notify the City by October 29 and none did so;


NOW THEREFORE BE RESOLVED: those duly elected to the City of Vadenais Heights:

Council Member – Erik Goebel


