3. Approval of May 6, 2024 Agenda: Motioned by William Kempe, and seconded by Jonathan Schumacher. Unanimously approved by all members present.

4. Approval of the February 5, 2024 Minutes: Motioned by John Niedfeldt-Thomas, and seconded by Jonathan Schumacher. Unanimously approved by all members present.

 - b. Updates on Requested Opinion of the Attorney General Presented by Rachel Tierney, Attorney, Kennedy & Graven

Rachel provided an overview of the petition and provided an update on the status of the request for an opinion from the Office of the Attorney General regarding the number of signatures needed on a petition to amend the Ramsey County Home Rule Charter (See attachment Rachel Tierney – Kennedy and Graven Memo and Attorney General Opinion). Charter Commission members were given an opportunity to discuss the opinion, asked clarifying questions, and discussed next steps.

Rachel's recommendations to the Charter Commission members were:

1. Inform the (Petition) Committee that the petition requesting the proposed Charter amendment must contain at least 15,740 signatures in order for the proposed charter amendment to be presented to voters for approval at an election.

Assuming that the petition is received, the County Manager is the office to review, and signatures have to be validated – registered and reside in Ramsey County. Under state law, the Elections Office has 10 days to verify and confirm signatures.

The Charter Commission will need to hold a special meeting to verify the petition. Assuming there is valid petition, somebody needs to write the ballot language. It can be Rachel Tierney as the outside counsel.

- Component of Ballot language: Title and body language. It needs to describe
 what the change will be because state law is silent on ballot language, the
 recommendation is to have Charter Commission and the Board adopt the ballot
 language.
- Report to county auditor need to be made within 74 days of an election.

 Assuming that the petition is received, it has to be adopted by August 23, 2024.

Motion by Bethany Winkels and seconded by William Kempe to accept the outside counsel recommendation of 5% of registered voters (15,740 signatures) of the last previous state general election in 2022. Unanimously approved by all members present.

- 2. Executive Committee be ready to work on drafting ballot language prior to introduction with Rachel Tierney.
 - a. Acting Executive Committee made up of Chair, Vice Chair, Jazmin Glaser-Kelly, Gloria Bogen, and Jonathan Schumacher.

Motioned by Bill Kempe, seconded by Jonathan Schumacher for the Executive Committee to meet with Rachel Tierney to draft a ballot if a valid petition is received. Unanimously approved by all members present.



c. Presentation: Ramsey County Parks and Recreation - No Net Loss Charter Provision Mark McCabe, Director, Ramsey County Parks and Recreation

Mark reviewed current challenges regarding the acquisition and disposal of park property since at the time that the charter provision was amended there was not an established baseline quantity of parkland and therefore there is not a quantity of parkland to peg the "no net loss" of parkland to.

Parks & Recreation would like to establish a baseline acreage of parkland which would ensure that a set quantity of parkland would be preserved for public utilization and to listen to Charter Commission member feedback. Ultimately, in order to establish a baseline quantity of parkland acreage Parks & Recreation would need to bring forward a request for Board Action to the Ramsey County Board of Commissioners for approval (See Ramsey County Parks and Recreation Presentation – No Net Loss Charter Provision attachment).

Ramsey County Priorities That Passed


- \$1 million for Union Depot Passenger Rail Insurance Increases
- Statewide \$3.4 million for DHS unsheltered funding
- Tax forfeiture settlement & policy bills
- Workforce omnibus bill \$300,000 for Ramsey initiatives
- Anerobic Digester \$5 million
- African American Family Preservation Act pilot program \$2.5 million
- Extended Producer Responsibility for Packaging Waste

- Changes to Ramsey County's HRA authority

What's Next?

- 2024 November Election
 - One Ramsey County legislator retiring (Rep. Jamie Becker-Finn)
- Senator Morrison resignation & special election
 - Creates a possibility to flip the Senate majority
- New Presidential Candidate Kamala Harris
 - Speculation around Governor Walz and possible change
- 2025 Budget Year
 - Starts later than normal: January 14th, 2025
 - New Ramsey County Manager & New Ramsey County Board

ROLE AND RESPONSIBILITIES: RAMSEY COUNTY CHARTER COMMISSION and its MEMBERS

- Support "good government", the overarching intent of the Home Rule Charter, to "...make
 county government more visible and responsive to the residents of the county and to provide
 ways to make county government more flexible and efficient in addressing the needs of county
 residents."
- Have an interest in learning about and discussion of Ramsey County
- Recognize the roles of elected officials vs those of Charter Commission Members
 - o Charter Commission Members are appointed by the District Court
 - o County Commissioners, Attorney, and Sheriff are elected by the citizens
 - the Charter provides the mechanisms for elected County Commissioners to make the policy decisions
 - the Charter provides the mechanisms for professional staff to design, develop, and deliver services for the citizens of the County
- Periodically review the Charter
- Propose any necessary amendments to the Home Rule Charter
- Oversee the amendment process including
 - Review of any proposed amendments
 - Declare the sufficiency of a petition
 - Prepare a summary of any proposed amendment
 - o Recommend any necessary revisions to proposed amendments
 - Submit proposed amendments to an election
- Attend all meetings of the Ramsey County Charter Commission
- Prepare for meetings by reading supplied documents prior to the meeting
