

PROJECT CONTEXT



The Bruce Vento Trail is an important community asset.

This trail extension project re-envisions the Bruce Vento Regional Trail as a 13.3 mile trail from downtown Saint Paul to the county boundary in White Bear Township.



PROJECT OVERVIEW



The Phase 2 extension will run 3.5 miles from Whitaker Street to County Road J in White Bear Lake and White Bear Township.

The Phase 2 extension will connect to the previously planned Phase 1 extension.

The new trail connections will benefit residents and businesses in the adjacent neighborhoods, while drawing new audiences to the trail system!



PROJECT HISTORY

1993: Master Plan for Bruce Vento Trail Completed

2018-19: Ramsey County initiates three design projects including Phase 1 Trail Final Design, Feasibility Study to evaluate alternate corridor for Phase 2 including a public engagement process, and initiate a master plan amendment for the Bruce Vento Regional Trail

2020: Preferred trail alignment for Phase 2 of the Bruce Vento **Regional Trail determined**

2020: Ramsey County prepares a Draft master Plan Amendment for long-term improvements to the Bruce Vento Regional Trail

November 2020: RFP for Phase 2 Predesign

January 2021: Begin Phase 2 Predesign

May 2021: Draft Amendment approved by Ramsey County Board of Commissioners

May 2021: Draft Amendment submitted to Metropolitan Council

- Prepare for final design, construction, and future grant requests.

- Provide a regional trail facility, amenities, and site components that incorporate sustainability and green infrastructure for long-term resiliency.




PROJECT ELEMENTS

PROPOSED BALD EAGLE AVE BETWEEN 4TH ST AND BALD EAGLE BLVD






PROPOSED BALD EAGLE BLVD OPTION 1

PROPOSED BALD EAGLE BLVD OPTION 2 BETWEEN PARK AVE AND HUGO RD






