COMMENTS AND CONVERSATIONS

THE FOLLOWING ARE NOTES AND COMMENTS FROM ATTENDEES, PROVIDED BY THOSE WHO STAFFED THE EVENT:

- Most people who attended were interested in seeing the streetcar project proceed.
- Multiple conversations with attendees concerned about corridor parking.
- Person equated Riverview to green line and thought that closed a lot of businesses.
- Space (Fort Snelling) was really nice, well-received.
- Most conversations were generally in favor of the project.
- Several attendees who spoke with MnDOT expressed that they think the West 7th project is a band aid and that Riverview would be the fix.

Resident from the Davern Station Area:

- Lots of support for the project and looking forward to it advancing
- Concern that the line should be more reliable and dedicated. One staffer shared that
 we're only talking about 1.5 miles difference between the two. Seemed like confusion
 that one option was dedicated, and one was not. Still thought that transit reliability was
 preferred over on street parking.

• Thought one of the best uses for him on this would be easier/faster connection to downtown Minneapolis. He did not have an issue with the transfer at Fort Snelling and thought that was a great advantage of streetcar over ABRT.
