The Notable Crimes Report is a weekly bulletin with some of the noteworthy crimes that occurred in Ramsey County for the given week. The purpose of this bulletin is to educate the community on crime trends and provide insight to the types of situations that law enforcement faces on a daily basis.

Carjacking/Robbery Suspect Arrested

Date and Time: March 27, 2021 at 7:24 pm

Location: 500 block of Case Avenue, Saint Paul

Officers responded to the 500 block of Case Avenue to locate a juvenile suspect. The suspect had been involved in numerous armed robberies/carjacking's throughout Saint Paul. The suspect was located and booked at the Juvenile Detention Center.

Pursuit of a Stolen Vehicle

Date and Time: March 27, 2021 at 9:22 pm

Location: 2400 block of Maplewood Drive North, Maplewood

Deputies assisted Maplewood Police in the pursuit a stolen vehicle that fled from officers. A PIT maneuver was attempted and was unsuccessful. The suspect fled into the area of Vadnais Heights and crashed into a deputy's squad car. A male suspect was taken into custody without incident. Suspect was booked for multiple felony warrants and other new felony charges.

Stolen Vehicle Taken in an Armed Carjacking

Date and Time: March 28, 2021 at 3:10 am

Location: Interstate 94 / White Bear Avenue North, St. Paul

Deputies assisted the Minnesota State Patrol who were attempting to stop a stolen vehicle that had been stolen in an armed carjacking in Minneapolis. The State Patrol initiated a traffic stop, but the stolen vehicle fled. State Patrol performed a PIT maneuver and then the stolen vehicle was boxed in by Sheriff's squad cars. Four juvenile suspects in the stolen vehicle were turned over to the State Patrol.

Fleeing a Peace Officer in Motor Vehicle

Date and Time: March 28, 2021 at 7:42 am

Location: Highway 10 / 85 Avenue Northeast, Mounds View

Deputies assisted Blaine police with a fleeing vehicle that was lost in the area of Mounds View. New Brighton police located the vehicle, then the vehicle fled. The vehicle was located by state patrol and found in Roseville. Roseville police attempted to approach the vehicle as the deputies assisted in perimeter. The vehicle fled and crashed. The suspect fled on foot and was apprehended by pursuing deputies.

Catalytic Converter Theft

Date and Time: March 29, 2021 at 12:09 am

Location: 4300 block of West Round Lake Road, Arden Hills

Deputies responded to a 9-1-1 call for an in-progress catalytic converter theft. The victim sounded their car alarm to scare off the suspects who fled, but not before cutting off half of the converter. Deputies received a description of the vehicle and plate. The vehicle had a previous owner who is a known catalytic converter thief. The suspect vehicle was located and two suspects were taken into custody. The driver had a felony warrant for auto theft.

Pursuit of a Stolen Vehicle

Date and Time: March 31, 2021 at 1:44 am

Location: County Rd East / Interstate 35E, Vadnais Heights

Deputies assisted Forest Lake police with a fleeing stolen vehicle on southbound Interstate 35E coming into Ramsey County. The suspect vehicle struck a utility pole and then crashed into an unoccupied vehicle in Saint Paul. A police canine track was conducted with no success in locating the suspect.

Attempted Carjacking

Date and Time: March 30, 2021 at 2:57 pm

Location: Hubbard Avenue & Holton Street, Saint Paul

Officers responded to a 9-1-1 call for an attempted carjacking by three juvenile suspects. Suspects tried to remove the victim from her vehicle but were unsuccessful. The juvenile suspects took her phone and fled in a vehicle that was stolen from Minneapolis.

Homicide

Date and Time: March 30, 2021 at 3:37 pm

Location: 1300 block of Arcade Street, Saint Paul

Officers were dispatched to the 1300 block of Arcade Street for a report of gunshots being fired inside of a business. The 9-1-1 caller reported that his friend was shot. Officers arrived and found the victim in the bathroom with multiple gunshot wounds. The victim died at the scene. A school nearby was put on a temporary lock-down until the area was safe.

Carjacking

Date and Time: March 30, 2021 at 3:39 pm

Location: 1200 block of Arundel Street, Saint Paul

Officers responded to the 1200 block of Arundel Street on the report of a carjacking. The victim was pushed out of her vehicle by three juvenile suspects and the vehicle was taken. The juvenile suspects attempted to take the victim's purse but were unsuccessful.

Terroristic Threats

Date and Time: March 26, 2021 at 4:10 pm 1700 block of 7th St W, St. Paul

Officers responded to the 1700 block of 7th St W on a report of terroristic threats made by a female suspect. The suspect walked into the store yelling that she was going to "blow up the place up" and took fuel additive off the shelf. She exited the store and poured fuel additive in the parking lot and on the gas pump. The suspect was taken into custody.
