Fleeing in a Motor Vehicle / Warrant Arrest

Date and Time: June 18, 2021 at 7:57 pm

Location: 4400 block of Centerville Rd, Vadnais Heights

Deputies were dispatched to a domestic disturbance in a parking lot. Deputies arrived and learned the vehicle the male was driving was stolen and the male suspect had a felony warrant. The suspect fled in the vehicle initiating a vehicle pursuit on 35E. The pursuit ended at the intersection of Centerville Rd. and Edgerton St. Male suspect fled on foot and was apprehended.
