WATER EXHIBITION PERMIT APPLICATION AND THE PLACEMENT OF WATER STRUCTURES IN THE LAKE(S) RELATED TO THE EXHIBITION

Applicant agrees to defend, hold harmless and pay on behalf of the County of Ramsey, its Municipalities, the White Bear Lake Conservation District and the elected officials, agencies and the employees of each, any demands or suits arising out of actions of the applicant under this permit.

Applicant will obtain and pay for a Comprehensive General Liability insurance policy in the amount of \$1,000,000. The policy shall name the County of Ramsey, its Municipalities, the White Bear Lake Conservation District and the elected officials, agencies, and employees of each as additional insured for the term of the permit. **Certificate of insurance shall be attached to this completed application and non-cancelable.**

MN State Statute 86B.121 RACES, COMPETITIONS AND EXHIBITIONS.

- a) A person may not hold or sponsor any scheduled or public race, regatta, tournament or other competition, exhibition or trial race on water or ice whether or not involving watercraft, without first having obtained a written permit from the Sheriff of the County where the event is to originate.
- b) The Sheriff may exempt watercraft from any of the provisions of this chapter relating to the licensing, operation and equipment of watercraft while participating in the event authorized.
- c) The County's issuance of a permit under this section does not make the County liable for any injury occurring at the event.


