One Stop Operator Consortium Update

Guetzkow, Garbe, Gerdin and Germain provided an update on the efforts of the One-Stop Operator consortium in 2024. The OSO is a consortium of One-Stop partners that coordinates services provided by all the mandatory One-Stop partners to help job seekers and employers. The group has been busy planning for of the CareerForce relocation to Metro Square which will open in March. They shared the services and operations highlights for 2024 and some client service metrics at the CareerForce and the Ramsey County Career Labs. County and state staff will be working together in the new CareerForce location with the goal of seamless service delivery and providing a better experience for customers, partners and staff. Milbrandt shared that a billboard on University Avenue is forthcoming to let the community know that the CareerForce Saint Paul is moving.

Legislative Updates: Current Political Landscape from a Federal, State and Local Perspective

Perlich lead a discussion with panelists Cate Duin, Executive Director of the Minnesota Association of Workforce Boards (MAWB) and Jolie Wood, Ramsey County Government Relations, regarding the current political landscape from a federal, state and local legislative perspective. Ramsey County legislative priorities include a need for more dollars for a variety of workforce development initiatives, such as ensuring business needs are met while supporting job seekers; addressing existing economic, racial and gender disparities; and supporting ongoing state funding to provide workforce programming to those who are unemployed, underemployed or underrepresented in the workforce. Despite the volatile political climate, MAWB and the county's government relations team will continue to work with Minnesota House Labor and Workforce Development Finance and Policy Committees (Rep. Pinto and Rep. Hussein) to advocate for support for workforce development.
