Staff Updates

Milbrandt provided updates on the following:

Local Plan & Subsequent Designation Approval: The 2024-2027 Local Plan was approved. Every two-years every Local Workforce Development Area needs to be re-designated to continue receiving funds. An official letter from the governor regarding the Local Plan and redesignation approvals is expected soon. National Disability Employment Awareness Month: This is an annual celebration in October recognizing the contributions of people with disabilities to the economy and workforce. This year's theme is Access to Good

Jobs for All, which reflects the commitment to expanding the number of good-paying jobs for people with disabilities. Manufacturing Month: October is Manufacturing Month. The manufacturing industry plays an important role in our local economy and is critical to the economic strength and vitality of our state. There is a Manufacturing Month page on the county's website with resources, data and events. One event is the Future of Work manufacturing panel on October 7 at Rondo Library. This is an opportunity for workforce

development professionals to learn about the latest trends, technologies and career opportunities in

manufacturing.

Upcoming Events:

- MN Skills Based Hiring Accelerator: These half day in-person workshops center on candidates capabilities rather than credentials, etc. The upcoming workshop dates are October 29 in Burnsville and November 19 in Minneapolis
- Youth Works! Networking: Hosted twice a year by the Youth Committee to bring those who support Ramsey County youth together. Fall event will be held at Rondo Library
- Career Connect Day: This will be the third annual event hosted by the St. Paul Area Chamber at the Saint Paul RiverCentre on October 15. This is an opportunity for local high school students to explore future career paths. Once again, transportation for all Ramsey County high school students will be sponsored by the WIB. All WIB and Committee members are asked to spend time in our both talking with students.

Workforce Solutions Leadership Transition: Former Workforce Solutions Director/WIB Executive Director Becker has transitioned to being the County Manager as of September 1. Michelle Belitz is serving as Interim Director. Deputy County Manager Kari Collins is leading the search for a new director. The position has been posted with the hope of having it filled by the end of the year. Input from the WIB on the desired attributes of the new director is being sought and the WIB will be represented on the hiring panel.

Racial Equity Framework Training

As background, McIntosh shared that the WIB's Equity and Executive Committees have been planning to do an equity training with the WIB this year. The Equity Committee considered several options before learning that the County Manager's Office set a goal to provide the county's racial equity framework training to all community members serving on formal county boards and commissioners by 2030. To support this goal, Jason Yang, Planning Specialist with the County Manager's office led today's learning session.
